## Narrative

---

On 09/25/18 at 1152 hours Person Reporting Nirmalya Chatterjee came into Northwest Area Command to report the following for Malicious Destruction of Private Property.

On 07/24/2018 Chatterjee said while changing the access codes to the temple video camera system, the technician, the temple administrator, and the priest noticed that audio conversation within the temple were being recorded. Chatterjee said the audio connection was immediately disconnected. Chatterjee stated that they can have video taping inside the temple but they're not to record any audio.

On 08/01/18 Chatterjee said the video camera system went down and so on 08/02/18 the technician, the temple administrator, and the priest entered the camera room and found that the DVR was damaged. Chatterjee said the door to the camera room was not damaged so there was no forced entry into the camera room. Chatterjee said the DVR equipment was taken to a shop to be repaired, it was found out that the data were wiped out from the hard drive, and the mother board was destroyed. Chatterjee said a new DVR has been installed since then.
